It is to inform you that the Final List of Candidates selected for Central Sector Scheme of Scholarships for College & University Students for the year 2010-11 (Fresh) (i.e. IPE March 2010) of your College is enclosed herewith. In case the students get equal marks, marks obtained in Physics, Chemistry and English (for Science Stream), Commerce, Economics and English (for Commerce Stream) and Civics, Economics and English (for Humanities Stream) in the order of preference are taken into consideration for final selection of the Candidates.

2. You are requested to bestow your personal attention upon effective implementation of the Scheme by adhering to the following guidelines.

- a) The Candidate shall not avail any other Scholarships, which do not include fee reimbursement. The candidates who have already received Scholarship from Government of A.P. or any Government Agency during 2010-11, should refund the same to the concerned Government / Agency through challan under concerned head of account and a copy of the same may be sent to this office.
- b) Scholarship amount is being transferred online directly to the Bank Account of the students as furnished in the application. Those candidates, who did not furnish Bank A/c No. in the application or who furnished Bank Account Nos. which do not have online facility have to be advised to open Account in any bank, which has online facility and the particulars should be sent to this office in the following format.
- c) The Principal is also informed to ascertain the similar information from the students, who were selected for Central Scholarship in the earlier years i.e. 2008-09, 2009-10 and could not receive the Scholarship amount for want of online Bank Accounts and furnish to this office in the same format.

The Scholarship amount for the year 2010-11 (Fresh) can be released after receipt of the above information.

- 3) (a) Blank renewal application forms, which are sent herewith may be filled by your office for each individual student as per the sanction list of 2010-11 (fresh) (i.e. IPE March, 2010 Candidates) and the same may be sent for renewal of Scholarship for the year 2011-12 by your office for the students who fulfill the following conditions. (Enclose a copy of 1st Year Degree Marks Memo).
- (b) Further, the Renewal Application forms for the Scholarship holders of 2008-09 Batch (i.e. IPE March, 2008) for whom 1st Renewal Forms for 2009-10, 2nd Renewal Forms for 2010-11 are not submitted earlier, may be sent immediately and for the same candidates 3rd Renewal forms **for the current year 2011-12** by enclosing a copy of 3rd Year Degree Marks Memo may be sent now.

(c) The Principals are further informed that in case of 2008-09 Batch students of Non-Professional Courses, such as BA, B.Com. B.Sc. Degree Courses, they might have completed Degree Courses by now and some of them might have joined in PG Courses in the same stream, for which they are eligible for continuation of Central Scholarship for PG Courses also i.e. for consecutive 4th and 5th year. **Therefore, the Principals are requested to inform the final year students, who are receiving Central Scholarship and who left the College to furnish the PG Admission particulars, in the renewal format through the Principal of PG College.**

(d) Similarly, for the Scholarship holders of 2009-10 Batch (IPE, March, 2009), the 1st renewal forms for the year 2010-11 may be sent immediately, if not submitted earlier and for the same candidates the 2nd Renewal forms **for the current year 2011-12**, may be sent now by enclosing copy of 2nd Year Degree Marks Memo.

4) If any Candidate is not found eligible for sanction of the above Scholarship / Renewal, due to any reason, viz. if the student has dis-continued the studies or is in receipt of any other Scholarship, the Principal should specify clearly, so that this Scholarship amount will be forfeited to the Govt.

5) The Format of Renewal Application, which is sent herewith may be Xeroxed in required number and the information may be submitted with full particulars in the Format **for each student and for each year separately.**

6) It is also observed that certain Universities are giving Marks in CGPA and accordingly the Marks secured by the students in their Degree Course Annual Examinations, are being mentioned in CGPA in the Annual / Semester Examination, without conversion into year-wise percentage of marks. **They are therefore requested to convert the CGPA into % of Marks & furnish year-wise % of Marks in the Renewal Application Form invariably.**

7) **The College wise, final selection lists of candidates of IPE, March, 2008, IPE March, 2009 and IPE March, 2010 and Renewal application Format are placed in the BIE's website www.bieap.gov.in which can be downloaded and also Xerox copies may be used, if necessary.**

8) **Conditions to be fulfilled for getting eligibility for Renewal of Scholarships:**

- i) The candidates should be promoted to next class and secure atleast 60% marks in the I / II / III or 1st (P.G) year bachelor degree course, as the case may be.
- ii) The candidates should put in 75% of attendance in the respective academic years & should have good behaviour / conduct.
