Sub: IPE March 2012 – I year & II year (Regular & Private) – Certain instructions to be followed for updation of corrections in I year data and uploading of students data online for II year candidates - Reg.

Adverting to the letters under references 1st to 4th cited, all the Principals of the Colleges are aware that online application developed by CG.G. (Centre for Good Governance) have been utilizing for online capturing students' admission register for the academic year 2011-2012.

In the reference 2nd cited, certain exemptions and concessions extended to Blind, Deaf, Deaf and Dumb, Physically disabled candidates, and also issued to the candidates suffering from DYSLEXIA and Mentally Handicapped.

In the reference 3rd cited, instructions were also given to follow while sending the hardcopy of I year NR to Regional Inspection Officer of the district concerned after payment of Examination fees.

FIRST YEAR:

Category Code	Description
1	<i>Regular candidates appearing for the first time for I year subjects / papers.</i>
2	<i>Candidates appearing for 'Improvement' having passed all subjects / papers in one attempt (provision is made to appear during Intermediate Advanced Supplementary Examination only)</i>
3	<i>Failed candidates of I year appearing for I year papers in part(s)</i>
5	<i>Exempted candidates appearing for first time for I year papers.</i>

It is informed that I year data i.e., Nominal Rolls and photos of the candidates for Intermediate Public Examinations, March 2012 are now placed in BIE's website (bieap.cgg.gov.in) for uploading of data i.e., verification and necessary corrections if any, and confirmation of the data.

In the reference 4th cited, due dates for payment of examination fees for II year Regular and Ex-students (General & Vocational), Attendance exempted candidates appearing for Humanities (without college study) and with change of group, are communicated for IPE March 2012.

It is informed that the Extracted Nominal Roll of the candidates appearing for Intermediate Public Examinations, March 2012 i.e., II year Regular and Ex-students (General and Vocational) are placed in BIE's website (bieap.cgg.gov.in) to upload the fees payment particulars. Certain applications / proformas to upload the candidates data, (category-wise) is being placed in the website very shortly.

II YEAR REGULAR :

Category code:

1. Regular candidates appearing for the FIRST TIME TO THE SECOND YEAR EXAMINATIONS.
8. Candidates admitted regularly into second year on T.C. (candidates who have appeared first year during March / ASE 2011 and took admission on TC in second year in other college).
9. Candidates **readmitted** into Second year (the Roll No, range should be of March 2011 or earlier to March 2011)

II YEAR PRIVATE :

Category code:

2. Improvement candidates reappearing after passing the IPE (within two years after passing the IPE the candidate can avail two chances only).
3. Failed candidates appearing in all 2nd year papers including Practicals or appearing in all 1st year and 2nd year papers including Practicals to secure a division.
4. Failed candidates appearing in some papers of 1st year or some papers of 2nd year, eligible to receive Compartmental Pass Certificate.
5. Candidates appearing for the 1st time for I & II year under exemption from attendance.
6. Candidates appearing for 2nd year for the first time with or without one or more papers of 1st year i.e., 1st year Memo holder.
7. Candidates appearing for Additional Subjects i.e., Intermediate Pass Certificate holders appearing Mathematics, II Language, etc., as Additional Subjects (File Rc No.908/C26-2/ March 2007).

NOTE: Candidate appearing for the 2nd year for the first time:

Regular, Private and Exempted candidates (i.e., 1st year Memo holders, discontinued and sought for exemption from attendance for 2nd year examination) appearing for the 1st time in the 2nd year examination in all 2nd year papers along with or without some or all 1st year papers, the Nominal Rolls of such candidates are CLASSIFIED AS CATEGORY-6 and are eligible for division.

- 1) Certified that the ENRs have been verified with reference to the particulars furnished by the candidates and in their memoranda of marks and that all additions, deletions and corrections have been correctly furnished.
- 2) Certified that the fee paid by the candidates is in accordance with the due dates and rates prescribed by the board.
- 3) Certified that the candidates furnished in the list of nominal rolls after corrections, are eligible to appear for II year examinations March 2012
