All Principals of Govt. Jr Colleges are aware that the application developed by Centre for Good Governance is being utilized for capturing students' admission register online for the academic year 2011-12. The Colleges have already captured around 7.67 lakhs students' admission particulars online. However, uploading of photo and signature of the candidates is getting delayed for want of certain facilities like Digital Camera and Electronic digital pen tablet.

It is observed under reference 2nd cited, that some of the Govt. and Aided Junior Colleges do not have adequate facilities like Computer, Printer, Digital Camera, Electronic digital pen tablet. Hence, the Principals of such colleges are accorded permission for purchase of the following equipment from the accumulated Special Fee funds of the Colleges concerned with the following configuration and permissible rates.

Digital Camera -- 8 - 10 Mega pixels (Cost around Rs.5,000/-)
(Preferably of Sony make)

Electronic digital pen tablet -- Starting model (Size 4 x 3) (Cost around Rs.2,000/-)

The Principals are instructed to adhere to rules while purchasing the above equipment from accumulated Special Fee Funds.

The DVEOs are instructed to advise the Principals on the procedure to be followed. They are also instructed to see that no amount is collected from students for this purpose. In the colleges where accumulated funds are not available, they are permitted to hire a Photographer for this limited purpose and pay @ Rs.5/- per student from the Special fee funds .

Where it is not possible either to purchase or hire the facilities, RIOs shall initiate steps to carry out this entire work in the neighbouring colleges on time.

Therefore, all DVEOs / RIOs / Principals of the colleges concerned are requested to take necessary measures immediately for completion of the work on time, to meet the academic schedule of 2011-12.
