In continuation of the press release issued vide reference 3<sup>rd</sup> cited, it is informed that the due dates for payment of **examination fee** by 1<sup>st</sup> year Regular (General and Vocational) students, Attendance exemption granted private candidates (without college study) and candidates who wish to appear with change of group for the ensuing Intermediate Public Examinations, March 2012 **are extended** as detailed below:

All the private candidates who have submitted their applications for exemption from attendance (without college study) for Humanities groups have to answer the papers on par with the syllabus prescribed for the regular students of the academic year 2011-12. The other instructions issued vide this office letter 2<sup>nd</sup> cited holds good.

**It is informed that there will be no further extension of examination fee due dates.** The candidates who fail to pay the examination fee even with late fee should invariably apply for Tatkal scheme only which will be announced in the month of November 2011. As such all the Principals and Managements are requested to give wide publicity about the above fee due dates among the students, parents and the staff of their respective colleges.
