It is to notify that the Intermediate First and Second year Regular and Private candidates who have not paid the Examination fee within the prescribed due dates and the candidates seeking Attendance Exemption (for Arts Group only) can pay the Examination fee in Tatkal Scheme for Intermediate Public Examinations March, 2012.

**TATKAL SCHEME will be made available from 28-11-2011 to 08-12-2011.**

- I. Under the Tatkal Scheme, the candidates will pay the Examination fee in their College and forward their applications from the Colleges where they have studied. They will take their Examination at the Centre allotted by the Board of Intermediate Education. Candidates have to pay the Tatkal examination fee in their respective colleges.

3.	I year examination fee Rs. <b>230/-</b> (Rupees Two hundred and Thirty only).
4.	II year examination fee Rs. <b>230/-</b> (Rupees Two hundred and Thirty only).
5.	I and II year examination fee Rs. <b>460/-</b> (Rupees Four hundred and sixty only).
6.	Practical examination fee as prescribed.
7.	Cost of Exemption and Examination application form is Rs.10/-+10/-=Rs. <b>20/-</b> (Rupees Twenty only).

**II. ATTENDANCE EXEMPTION CANDIDATES:**

A candidate seeking Attendance Exemption has to pay Rs. **500/-** in addition to the examination fee by way of Demand Draft in favour of the Secretary, Board of Intermediate Education, Andhra Pradesh, Hyderabad and submit Attendance Exemption form and Examination Application form along with demand draft to the **Principal of the Government Junior College** as per the above due dates along with original SSC, TC, Intermediate Memo of Marks (for Group Change candidates) and a set of attested copies.

a) Last date for submission of Exemption & Examination application forms by the candidate along with the Demand Draft and enclosures in the college is **08-12-2011**.

b) Last date for submission of I & II Year M. N. Rs of Attendance Exempted candidates along with Demand draft and enclosures by the Principal in R.I.O Offices is **09-12-2011**.

c) Candidates who have a gap of one year after passing the qualifying examination i.e., S.S.C. or its equivalent are eligible to appear only for first year examinations and who have a gap of two years after passing the qualifying examination i.e., S.S.C. or its equivalent examination are eligible to appear for both first and second year examinations as private attendance exemption candidates.

III. Intermediate Pass Certificate holders appearing for Mathematics as Additional subject have to submit the attested copies of Intermediate Pass Certificates in the colleges where they have studied previously.

**IV. THE FOLLOWING CANDIDATES ARE ELIGIBLE TO PAY THE EXAMINATION FEE UNDER TATKAL SCHEME.**

1. First and Second year Regular eligible candidates who have not paid the Examination fee in time.
2. Failed candidates who appeared for Intermediate Public Examinations, March 2008 and after wards.
3. Failed candidates of **2006-07 and earlier** have to appear for all the subjects/papers as fresh candidates as per the existing provision.
4. The candidates admitted into Intermediate Course during 2007-2008 are eligible to appear for Intermediate Public Examinations, March 2012 and Intermediate Public Advanced Supplementary Examinations, May/June 2012 as a last chance and they cannot claim their old performance to clear backlog papers.
5. Intermediate Pass Certificate holders who passed Intermediate in March, 2010 & IPASE 2010 and afterwards to appear for **IMPROVEMENT** of their performance.
6. Candidates willing to appear for Intermediate examinations with change of Group in Arts combination. Intermediate Pass Certificate holders appearing for Mathematics or II Language as additional subjects under Attendance Exemption.
7. Candidates willing to appear privately with Attendance Exemption Scheme (for Arts group only).

The above due dates are applicable to both General and Vocational students and also Attendance exempted private candidates for Humanities only (without college study) and who wish to appear with change of group for the Intermediate Public Examinations, March 2012.

Incomplete applications and the applications without required enclosures will be rejected.
